## DECISION

Regarding the establishment of the 2024 Admissions Council

### RECTOR OF THAI BINH COLLEGE OF MEDICINE

*Pursuant to Circular No. 15/2021/TT-BLDTBXH dated October 21, 2021 of the Ministry of Labor, Invalids and Social Affairs stipulating the Charter of Colleges;*

*Pursuant to Decision No. 2069/QD-UBND dated September 18, 2023 of the Thai Binh Provincial People's Committee stipulating the functions, duties, powers, and organizational structure of Thai Binh College of Medicine;*
